- 1. The "Dr.K.V.Subba Reddy Institute of MCA, Opp.Dupadu Railway Station, NH-7, Lakshmipuram (Post), Kurnool" was given Temporary affiliation for running Degree courses during the academic year 2011-12 vide Procs.(1) read above.
- 2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2012-13 vide ref (2) and (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2012-13 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2012-13. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2012-13 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 30-11-2012

1. Atleast two Governing Body meetings should be conducted in an year

2. Computer to student ratio should be improved from 1:9 to 1:2. 200 more computers should be procured

Computer labs are properly established

4. 1000 more books should be added to the library

5. Journals are not subscribed, should be subscribed as per AICTE norms

6. Xerox machine facility should be provided in the library

7. Digital library should be established and NPTEL learning resources should be procured.

8. Separate examination section should be created

9. Teacher to student ratio should be improved from 1:26 to 1:15 in MBA & MCA departments
